Philosophy and Approach: I respect the needs of clients; together we will formulate goals that address what is most important to your well-being. I utilize an eclectic theoretical framework, though have extensive experience utilizing emotionally focused therapy within a person-centered approach. My initial training focused on a psychodynamic orientation, and still informs the work I do with clients. This translates into being able to talk about concrete ways to meet objectives, while also looking at what might be the root cause of your distress.

Formal Education and Training: I hold a master's degree in art therapy counseling from Marylhurst University. My training includes verbal and art therapy. I have completed two levels of Emotionally Focused Therapy training for work with couples. I am Licensed Professional Counselor (LPC) and a registered art therapist. My major coursework included Human Growth & Development, Group Dynamics, Assessment & Counseling Skills, Art Therapy, and Psychopathology.

I have been a professional therapist since 1996 and have worked with a variety of clients in that time, both in community mental health agencies and private practice. I have addressed a variety of client issues, including grief and loss, family conflict, past sexual abuse, family of origin effects, symptoms of depression and anxiety, and struggles with self-esteem and self-concept.

As a Licensee of the Oregon Board of Licensed Professional Counselors and Therapists:

As a licensing requirement, I regularly attend trainings for continuing education in the counseling field. I have contracted for clinical supervision throughout my career and engage in consultation to maintain the highest standards of professional practice.

Fees and Appointments:

I offer an initial free 30-minute consultation. Initial intake assessments are \$165.00. The fee for 60-minute individual and couple sessions is \$135.00. If I am not on your insurance panel, we can discuss submitting a bill for reimbursement. However, full payment is required at the conclusion of each session. I offer a limited number of sliding scale appointments for those that cannot afford my full fee. The sliding scale is posted on my website and we can discuss it during the initial consultation. I accept cash, checks or credit cards.

If payment is not received at the end of a session, or there are any fees owed for missed appointments, the balance owed must be paid before another session can be scheduled.

If you are unable to keep your appointment, 24 hour notice is required. Except in the case of an emergency or illness, you will be charged \$60 for any sessions missed without a 24-hour advance notice. The telephone number at the top of this page is available 24 hours a day. I check my messages frequently throughout the day. In the event of a mental health crisis, please call the Multnomah County Crisis Line at 503-988-4888.

As a client of an Oregon licensee of the Oregon Board of Licensed Professional Counselors and Therapists, you have the following rights:
